Checks should be payable to Bond County Collector.  
Cash, Certified Funds and Credit Cards are also accepted in the office. Additional fees apply to Credit Cards.  
Banks can only take full payment before the due date and can not accept credit cards.

Failure to receive a tax bill, or receiving one late for any reason, **does not** relieve taxpayer from paying taxes or any late penalties accrued.

This is the only tax bill you will receive.

**Credit Card / Debit Card transactions have a non-refundable convenience fee of 2.50% of the transaction plus \$1.50 (minimum is \$2.95) which is not received or kept by the county.**

A \$10 fee will be added when delinquent notices are mailed.  
A Tax Sale will be held for all unpaid taxes and fees.  
No personal checks are accepted within 30 days of tax sale.

ILLINOIS LAW PROVIDES THAT ALL TAXES NOT PAID BY INSTALLMENT DUE DATES SHALL HAVE PENALTY ADDED AT THE RATE OF 1.5% PER MONTH.
